

## PRIVACY NOTICE REGARDING CALIFORNIA RESIDENTS

This Privacy Notice describes how Exelixis, Inc. and its representatives, agents, and contractors, including McKesson Specialty Arizona ("McKesson") and other specialty pharmacies (collectively, our "service providers") may collect, use and disclose personal information of California residents for providing services relating to the EASE program and/or the 30-day free trial and related purposes, as described herein and in the Patient Authorization Form. For general information about how Exelixis may process personal information, please visit www.exelixis.com/privacy.

**Categories of Personal Information Collected.** We may obtain certain personal information you or your healthcare provider may provide when you or your healthcare provider submit the EASE Enrollment Form or otherwise provide your information to us or our service providers, including the following categories of personal information:

- identifiers and related information, such as name, date of birth, address, email address, phone number, gender, and certain of the foregoing information relating to any alternate contact;
- financial or insurance information, such as medical insurance information, prescription drug insurance information, and certain information relating to your income or economic situation;
- medical information, such as diagnosis, diagnosis date, therapy line, current medications, allergies, prescription and pharmacy details, and your prescriber and healthcare provider; and
- other information you or your healthcare provider may provide to us or our service providers.

Some of the information we collect such as medical information constitutes sensitive personal information under applicable privacy laws. We process such information in compliance with applicable privacy laws and consistent with the disclosures herein.

Purposes of Collection. We may collect and process personal information for the following purposes:

- providing the services offered by the EASE program, including the Co-Pay Assistance Program or Patient Assistance Program;
- undertaking financial support services, including benefits verification, potential out-of-pocket costs, and eligibility for financial assistance;
- to see if you qualify for patient assistance;
- facilitating the dispensing of medication, supplies, or services;
- providing product support services;
- undertaking other online support, education, and assistance services; and
- providing you with promotional information regarding offers, services and programs that may be of interest.

Exelixis also receives certain information from its service providers from which name and other identifiers have been removed, which it uses to conducting market analyses and to support other internal business operations. Exelixis does not retain keys or other identifiers that would allow it to re-identify such information, and by policy prohibits its employees from doing so.

**Disclosures of Your Information.** We and our service providers may disclose your personal information to each other for the purposes described above, to governmental or other entities if required to comply with law or valid legal process, or if we have a good faith belief that access, preservation or disclosure of such information is reasonably necessary to protect the rights, property or safety of Exelixis, our customers, or the public. We also may disclose such information in the event of a transfer of control of Exelixis or the sale of substantially all its assets, subject to appropriate confidentiality protections. We do not sell your personal information collected as described herein to third parties or share it for purposes of cross-contextual behavioral advertising.



## PRIVACY NOTICE REGARDING CALIFORNIA RESIDENTS

**Retention.** We retain your personal information collected as described herein for no longer than necessary to fulfill the specified purposes for collection and use (or a reasonable time thereafter) or other compatible purposes including satisfying legal requirements.

California Resident Rights. California residents may have the right to (i) request additional disclosures about the personal information we collect, use and disclose, (ii) request access to your personal information, (iii) request to correct inaccurate personal information; (iv) limit our uses of sensitive personal information; and (v) request that your personal information be deleted. You will be required to supply a valid means of identification to verify your identity and, if made through an authorized agent, provide written proof that the agent is authorized to act on your behalf. If we retain information relating to you in a form in which we cannot reasonably associate it with you, we will not attempt to re-identify the information to comply with your request. Please note that the foregoing rights are not absolute, and we reserve our rights available under applicable laws to limit or decline to comply with your request.

We and our service providers will not discriminate against you for exercising any of these rights. However, we may provide a different level or quality of goods or services, if that difference is reasonably related to the value provided to you by your data.
